That question's related to the musculoskeletal system, but the test won't come right out and say so. If you fail your first test, you are allowed one free retake. **GETTING CERTIFIED** Once you pass the CPC exam, you are not officially certified by the AAPC until you fulfill a few other criteria. Certification is also limited to coders with two years of professional experience or those willing to complete an apprentice program.
