THE MANUAL MAY STRUGGLE TO ADEQUATELY ADDRESS THE SPECIFIC NEEDS AND VULNERABILITIES OF DIFFERENT GROUPS, POTENTIALLY LEADING TO BIASED OR UNFAIR OUTCOMES. FINALLY, THE GROWING BACKLOG OF ASYLUM APPLICATIONS IN MANY COUNTRIES HIGHLIGHTS THE LIMITATIONS OF THE CURRENT APPROACH. THE MANUAL'S EFFECTIVENESS IS OFTEN UNDERMINED BY OVERBURDENED SYSTEMS AND A LACK OF RESOURCES.
