CONFLICT RESOLUTION: HOW DO YOU TYPICALLY HANDLE DISAGREEMENTS?

PARENTING PLANS: WHAT ARE YOUR VIEWS ON RAISING CHILDREN (IF APPLICABLE)?

RELIGIOUS AND SPIRITUAL BELIEFS: WHAT ROLE DOES RELIGION OR SPIRITUALITY PLAY IN YOUR LIFE?

HOUSEHOLD CHORES AND RESPONSIBILITIES: HOW DO YOU ENVISION DIVIDING HOUSEHOLD TASKS?

A WELL-CRAFTED SET OF "20 QUESTIONS ABOUT THE BRIDE AND GROOM" SHOULD ADDRESS THESE KEY AREAS, ALLOWING COUPLES TO GAIN VALUABLE INSIGHTS INTO THEIR COMPATIBILITY BEFORE MAKING A LIFELONG COMMITMENT.

4. DATA AND RESEARCH FINDINGS: THE IMPACT OF PREMARITAL ASSESSMENT

5. ANALYZING RESPONSES: IDENTIFYING PATTERNS AND POTENTIAL CHALLENGES
